1. Introduction

The Guyana Forestry Commission (GFC) as the Standardising body, has prepared this report to meet the requirements of Clause 6.2 of PEFC ST 1001:2017, which deals with stakeholder identification. To be able to demonstrate during the PEFC assessment that the selection of stakeholders met the PEFC requirements, the Standardising body is required to document and keep records of organizations it contacted, as well as comments and/or inputs received during the initial engagement and subsequent public consultations.

Under the PEFC guidelines, stakeholder mapping requires that thorough consideration be given to identifying potential interest groups, to ensure they are suitable and appropriate for the standard development process. This requires ensuring that:

- organisations and their representatives selected are "truly" representative of the broad range of interests, views and values within the forest industry sector; and
- an appropriate, relevant and suitable communication strategy is developed and adopted, to encourage active and effective engagement and participation in the process by stakeholders.

2. Stakeholder identification

In 2012, the Guyana government and the European Union (EU) commenced negotiations on a Voluntary Partnership Agreement (VPA) under the EU's Forest Law Enforcement, Governance and Trade's (FLEGT) Action Plan established in 2003. The FLEGT Action Plan aims to reduce illegal logging by strengthening sustainable and legal forest management, improving governance and promoting trade in legally produced timber. The Guyana Forestry Commission (GFC) managed the Guyana-EU VPA negotiations on behalf of the government of Guyana.

As part of the negotiation process, the GFC undertook a comprehensive stakeholder mapping to identify the key and relevant stakeholder groups to be invited to support Guyana's negotiations. Through the stakeholder mapping, the GFC established the national technical working group (NTWG) to guide the negotiations with the EU. Subsequently, the GFC established the national implementation working group (NIWG), to guide implementation of the VPA, following initialling of the Agreement. Representatives from the multi-stakeholder NTWG and NIWG included members from the private sector, Indigenous bodies and Government agencies as follows:

- Forest Products Development and Marketing Council
- Guyana Revenue Authority
- Forest Products Association
- Guyana Manufacturing and Services Association
- National Toshaos' Council
- Indigenous Peoples' Commission
- Ministry of Foreign Affairs
- Ministry of Legal Affairs

- Ministry of Natural Resources
- Environmental Protection Agency
- Amerindian People's Association)
- Small Logger Representation
- Iwokrama
- National Insurance Scheme
- Ministry of Social Protection

As part of the stakeholder mapping for the National Certification System, the GFC in consultation with the PEFC Secretariat, decided to use the organisational membership of the VPA's technical working group and the implementation working group as the starting point.

The stakeholder mapping exercise commenced with a gap analysis of the membership of the national technical working group (NTWG) and the implementation working group (NIWG) for the VPA, against the requirements of PEFC ST 1001-2017. The gap analysis focussed on identifying affected and interested stakeholders, as well as those able to influence the Standard's implementation, not already included in the NTWG and the NIWG.

The gap analysis identified the absence of organisations representing women, youth, forestry workers and academia in the NTWG and the NIWP.

Based on the nine major stakeholder groups specified Clause 6.2.2 of PEFC ST 1001:2017, the GFC identified the stakeholder groups to be invited to discuss the merits of developing a national forest certification System for Guyana. The main stakeholder groups and their areas of interest identified by the GFC are as follows:

- forest owners
 - they are groups that produce wood products, and are likely to seek independent-third party certification under the system;
- business and industry
 - comprises individuals and entities involved in the wood products supply chain who may seek chain of custody certification under the system;
- indigenous people
 - some indigenous groups are both forest owners and also involved in the wood products supply chain. The main interest of indigenous stakeholders relates to how commercial forestry impacts on their cultural, economic and social well-being;
- non-government organizations
 - mostly environmental NGOs, who are interested in ensuring that the potential adverse impacts of any commercial forestry are minimised. The other group relates to the role of women in commercial forestry in Guyana. They are involved to ensure gender balance, as well as bring women's perspectives for consideration in the Standard's development.

- scientific and technological community
 - this group can influence the implementation of the Standard, as well as provide scientific and technological input and knowledge, to ensure the Standard remains dynamic to incorporate new knowledge based on science and research, as well as changing societal values on how forests should be managed for multiple use objectives.
- workers and trade unions
 - this group is involved to ensure issues related to the protection of workers' rights, including occupational, health and safety issues.
- government agencies
 - o their main interest is to ensure that the Standards meet government policies.
- Civil society organisations
 - their main interest is to ensure effective governance and fair distribution of community benefits and impacts.

On 5th March 2021, the GFC organised the First Scoping Meeting on online, to discuss with stakeholders the merits of developing a National Certification System for Guyana. Over 50 participants representing the key stakeholder groups the stakeholder mapping identified took part in the online First Scoping Meeting. A list and screenshots of the 53 participants at the First Scoping Meeting are at Appendices 1 and 7, and the 214 invitees is at Appendix 2. Public announcement of the online First Scoping Meeting, and invitation to key stakeholders within the Guyana forest and wood products sector are at Appendices 3, 4, and 5 respectively.

The Minister for Resources, Hon. Minister Vickram Bharrat, in his opening speech at the First Scoping Meeting, specifically informed participants that the objective of the meeting was to seek their views on whether they supported the development of the Standards and the National Certification System. A summary of comments from participants providing support to the proposal to develop the Standards and the national certification system are included in Appendices 6 and 8.

At the conclusion of the First Scoping Meeting, the GFC informed participants about the next steps, which included formation of the National Standard Setting Working Group (NSSWG), to guide the development of the Standards. The GFC invited each stakeholder group to nominate its representative for the NSSWG.

On 30th April 2021, the GFC held a second online First Scoping Meeting as part of the stakeholder mapping exercise. Twenty (20) participants took part in the Second Online Scoping Meeting. They comprised representatives nominated by the key stakeholder groups invited to participate in the First Scoping Meeting. The list of participants is at Appendix 9.

Prior to the Second Scoping Meeting, and as part of the invitation, the GFC sent to the stakeholders the Terms of Reference (ToR) for the NSSWG (Appendix 10), to assist stakeholders to select their representatives to the NSSWG. A draft of the ToR was discussed with the PEFC Secretariat, prior to finalisation.

At the conclusion of the Second Scoping Meeting, and subsequent discussions at the third stakeholder online meeting held on 8th May, participants agreed to the groups listed in Table 1 to constitute the NSSWG. There are twenty (20) stakeholder groups, representing five (5) sectoral interests.

3. Disadvantaged stakeholders

The stakeholder mapping process identified Indigenous groups and other stakeholders living outside large urban centres as "disadvantaged." This is because these group of stakeholders may lack ready access to electronic media.

To ensure disadvantaged stakeholders are able to participate effectively in the standard setting process, hard copies of documents will be made available to them through the network of GFC Forest Stations in all the forestry regions of the Country.

In addition, the GFC would facilitate access to Forest Stations, to enable disadvantaged stakeholder groups and/or their representatives, to use computers and other appropriate electronic devices to take part in online discussions and/or consultations.

Television, radio, newspapers, emails, radio and social media platforms will be used to inform all stakeholders about impending meetings, and also provide updates and progress on the standard development process.

4. Balanced representation

Under the PEFC guidelines, "balanced representation" does not only mean that the standard development process involves a lot of different interests around the table. It also means that the different interests receive balanced emphasis.

The GFC ensured balanced representation of interest groups was achieved by ensuring that representatives were drawn from the key stakeholder groups from Guyana's forest and wood products sector as follows:

- Forest owners and forest managers at all scales;
- Supply chain from harvest to end users;
- Local environmental organizations;
- International environmental organisations;
- Government agencies whose statutory responsibilities impact on the forests and forest products sector in Guyana;
- Research and academia;
- Workers' Union; and
- Community interests, including youth and women.

The GFC also ensured that the membership of the NSSWG included stakeholders with expertise relevant to the subject matter of the standard (e.g. academia and scientific community), those affected by the standard (FSOs), and those that can influence implementation of the standard (environmental organisations, indigenous organisations, workers' representatives and community interests, including youth and women). The affected stakeholders shall be represented in an appropriate proportion among participants.

The GFC has also ensured gender balance in its membership. At least, 14 primary and alternate women representatives are included in the overall membership of the NSSWG.

Members of the NSSWG will be required to consult with their relevant constituencies, and to bring forward the views and comments of their constituencies, which shall inform the decisions the NSSWG shall make.

The NSSWG will ask for evidence of consultation with constituencies by members on all issues central to the Standard setting process.

Given the PEFC's standard setting process is based on a balanced representation of all stakeholders who are related to sustainable forest management, the process will ensure that all these stakeholders have the same strength of voice, so as to avoid overruling of underrepresented interests.

The NSSWG will continually review its composition and membership, to ensure it meets the standard setting requirements of PEFC ST 1001:2017 (i.e., gender balance and balanced representation of affected and interested stakeholders, as well as stakeholders able to influence the standard's implementation).

5. Effective participation by stakeholders

The role of the standard setting working group is to build consensus on Guyana's forest management standard. To achieve this will require incentives, and appropriate and relevant support, so as to garner the effective involvement, commitment and active participation of individuals from the different interest groups.

While sometimes it could be challenging to convince individuals to invest their time in the process, the GFC has agreed to invest the necessary resources and provide required incentives, to ensure effective engagement and participation by all stakeholders.

Through the PEFC secretariat within the GFC, stakeholders will be provided with the necessary administrative and financial support, to participate in NSSWG meetings. While stakeholders will participate on a *pro bono* basis, the GFC will provide a small honorarium to members of the NSSWG, to cover out of pocket expenses incurred as a result of participating in the standard setting process.

It is important to ensure that all the relevant stakeholder groups and or their representatives participate, as well as invest their time in the process, so they can feel ownership of the outcome.

6. Achieving consensus

The PEFC guidelines define consensus building as "a group activity that forms agreement considering the views of all the stakeholders." In this context, stakeholders will ensure that no interest group dominates.

To achieve consensus and transparency, the standard setting process will utilize a range of approaches, including:

- face-to-face meetings, where a verbal yes/no vote, a show of hands; a formal balloting process; a secret ballot; or a statement from the Chair accompanied/unaccompanied by dissenting voices or hands;
- email conversations, in which agreement on an issue is sought, or objection by a written response (proxy vote);
- telephone conferences at which a verbal yes/no vote is taken; or
- combinations of the above or other suitable means.

7. Consultations with stakeholders

Because of restrictions due to COVID-19, stakeholder discussions and consultations will be done through online First Scoping Meetings and emails. Face-to-face meetings will resume once COVID-19 restrictions no longer apply.





Appendix 10: Structure and Terms of Reference for the National Standard Setting Working Group

Structure and Terms of Reference for the National Standard Setting

Working Group

PEFC

May 2021

a. PEFC Structure in Guyana

The Guyana Forestry Commission (GFC) is the governing body to develop a national forest management standard and certification system for endorsement by the Programme for Endorsement of Forest Certification (PEFC). As part of the process, a National Standard Setting Working Group is required. The primary role of the standard-setting working group is to build consensus on Guyana's forest management standard.

The GFC will provide routine updates to the **Ministry of Natural Resources** on the work of this NSSWG and overall coordination efforts on the development of the standard and certification system.

Collectively all work done by the NSSWG will inform the **Reports** that will be drafted by the PEFC Secretariat of the GFC, and will be submitted to relevant bodies (including the Ministry of Natural Resources) for purposes of providing updates, seeking policy level advice and guidance and for formal decision making at the policy level.

As outlined below, the **Terms of Reference** aims to provide additional details on the scope of work and modalities of the NSSWG.

b. Terms of Reference for the National Standard Setting Working Group

Scope:

The NSSWG will be responsible for developing a national forest management standard and certification scheme which will cover forest management on all timber sources where forest management for commercial purposes is permitted by law, including:

- individual forest management organisations and potential group schemes involving multiple forest management entities;
- · non-timber forest products as well as timber products; and
- · entities purchasing, processing and/or trading in forest products.

Composition of the NSSWG:

The PEFC requires that in selecting stakeholder organisations, consideration should be given to ensure that, to the extent possible, the following key sectors, based on the UN Agenda 21, are covered:

Business and industry;

- Large concession holders
- Small concession holders
- Processors
- Traders and retailers
- Exporters
- Non-governmental organisations;
- · Scientific and technological communities;
- · Farmers and small forest landowners;
- Workers and trade unions;
- Local authorities;
- Indigenous people;
- Women;
- · Children and youth.

The following organisations have expressed an interest or have been suggested to be involved in the NSSWG and have been invited to nominate their representatives.

Membership:

- 1. Guyana Forestry Commission
- 2. Ministry of Natural Resources
- 3. Guyana Manufacturing and Services Association
- 4. Forest Products Association

- 13. Ministry of Human Services and Social Security

Quorum:

50% + 1 of permanent members are required for a quorum to be met.

Administrative Coordination:

The GFC, through the PEFC Secretariat, will perform all administrative and coordination functions involving the work of the NSSWG.

Duration of Work:

The work of the NSSWG as guided by the Terms of Reference will be for the duration of the development of the standard and certification system.

Roles and Responsibilities:

The roles and responsibilities of the NSSWG include the following:

- developing the national standards and the certification system documentation, with executive support from consultants and the GFC;
- ensuring the national standards and system meet all relevant legal/statutory requirements and the unique structural settings and characteristics of forestry in Guyana;
- · ensuring the standards and system meet the requirements of forestry users in Guyana:
 - large concession holders
 - small concession holders
 - processors
 - traders and retailers
 - exporters
- · ensuring continuity of process through availability for meetings
 - if unavailable, brief alternate representative/substitutes fully to ensure continuity;
- building consensus on Guyana's forest management standard through incentives and appropriate and relevant support, to garner effective involvement, commitment and active participation of individuals from the different interest groups through a range of approaches, including:
 - face-to-face meetings, where a verbal yes/no vote, a show of hands; a formal balloting process; a secret ballot; or a statement from the Chair accompanied/unaccompanied by dissenting voices or hands;
 - email conversations, in which agreement on an issue is sought, or objection by a written response (proxy vote);
 - telephone conferences at which a verbal yes/no vote is taken; or
 - combinations of the above or other suitable means.

- ensuring that the standard-setting process is balanced in representation, transparent and participatory in approach;
- developing and keeping all documentation relevant to the standard-setting and review
 process to provide evidence of compliance with standard-setting requirements and
 internal procedures. These documents include:
 - o standard-setting procedures,
 - stakeholder identification mapping,
 - contacted and/or invited stakeholders,
 - stakeholders involved in standard-setting activities, including participants in each working group meeting,
 - o minutes of working meeting,
 - feedback received and a synopsis of how feedback was addressed,
 - all drafts and final versions of the standard,
 - outcomes from working group considerations,
 - evidence of consensus on the final version of the standard(s),
 - evidence relating to the review process, and
 - final approval by the standardising body.

Qualifications:

- While a formal qualification in the forest and wood products sector would be preferable, it is not required. However, members of the NSSWG would be expected to have an awareness and appreciation of critical environmental, social and economic issues within the forest and wood products sector in Guyana. In addition, members are expected to have the following skills and attributes:
 - proven ability to work effectively in a team environment;
 - commitment to transparency, collective accountability and consensus outcomes;
 - extensive networks within the stakeholder group they represent; and
 - demonstrated support for a sustainable commercial forestry sector in Guyana, including a commitment to manage and use the nation's forest resources to achieve multiple outcomes (environmental, social and economic).
- It is preferable for a member to represent one of the stakeholder organisations identified above based on the UN Agenda 21. However, an individual with unique skills, attributes and qualifications required and necessary for the Working Group's work may be invited to participate in their own right as individuals, even if they have no formal affiliation to a stakeholder group.

Working Approach/Style:

Working Group meetings may be arranged by the Chair of the WG or the PEFC Secretariat within the GFC.

- meetings can take place in person or via telephone/web conferencing facilities or a combination thereof;
- the agenda of an upcoming meeting and related papers would be distributed to the WG at least seven days before the meeting;
- members can submit to the Secretariat comments, requests for discussions, documents etc., with the request to be considered at the meeting, up to ten days before the meeting.

Confidentiality:

- WG members can communicate with their own stakeholders on topics arising within the WG, but they are not expected to do so in an inappropriately public manner, such as on websites, in newsletters, etc.; and
- any information that the WG requests to be kept as confidential by any WG members or the Secretariat must to be kept confidential.

Costs:

 Members of the NSSWG are expected to contribute their time pro bono. However, the GFC may pay a small honorarium to cover out-of-pocket expenses if a member is required to travel from their usual residence to Georgetown for meetings and/or consultations.
