

# GUYANA FORESTRY COMMISSION INVITATION/REQUEST FOR PROPOSAL/QUOTATION TO SUPPLY THREE (3) NEW 4 X 4 VEHICLES AS HEREUNDER DESCRIBED

#### **SECTION 1- INTRODUCTION**

The Government of Guyana/Guyana Forestry Commission has embarked on a national programme that aims to protect and maintain its forests in an effort to reduce global carbon emissions and at the same time attract resources to foster growth and development along a low carbon emissions path. Guyana has over 80% of its land area covered by forests, approximately 18 million hectares. Deforestation rate has been relatively low in Guyana estimating between, 0.1% to 0.3% per annum. Guyana is committed to provide a contribution to address the second most important source of carbon dioxide emissions worldwide coming from deforestation and forest degradation and is estimated at approximately 18% of global emissions.

## **Invitation for Quotation**

Submission must include the following information:

# **Background Information**

- a) Company Name and Contact Details and Background Information of the Company including experience and history of supply similar types of vehicles in particular to Government Agencies. In addition, information on the company's maintenance and after sales service should be provided.
- b) Delivery Schedule

- c) Duty Free Price for one vehicle and total cost for three (3) vehicles in accordance with the currency provision.
- d) Photographs showing full, interior and engine view of the model of vehicles propose to supply.
- e) GRA and NIS Compliances
- f) Business Registration
- g) Dealers Authorization
- h) Declaration of Good Standing (See Appendix 1)

# Language

Bids are to be prepared in English language.

# **Currency Provision**

Bids should done be done in Guyana Dollar.

#### Cost

Cost must exclude duty and excise tax and VAT i.e. free of duty and taxes. Please quote the unit cost and the total cost for the three (3) vehicles.

### **Defects Liability Period**

The defects liability period shall be 3 months following delivery of the vehicles to the GFC.

#### **Payment Terms**

Payment will be made after inspection, delivery and acceptance of the vehicle

# **Schedule for Delivery and Completion**

Vehicles must be delivered no later than 15 days following the notification of the acceptance of your quotation.

#### **Inspections and Tests**

The GFC shall have the right to inspect and/or test the vehicles to verify their conformity to the contract specifications. If the vehicles fail to meet the contract specifications during inspection the supplier shall take immediate steps to remedy the deficiency or replace the defective vehicle (s) to ensure that all supplies meet the specifications as specified in the contract.

#### **Limit of Retention**

10% of contract sum. This amount shall be released after the defects liability period would have expired.

#### **Warranty and After Sale Service**

The supplier will be required to provide at least three (3) years or 100,000 km manufacturer's warranty on all vehicles supplied. The supplier warrants that all vehicles are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials unless otherwise provided in the contract. Warranty shall be assigned to the GFC. The supplier is expected to provide free after sale service for a period of at least six months following delivery of vehicles.

#### **Penalties for Delays in Delivery**

A sum of US\$ 500 per vehicle shall be paid for every week that vehicle (s) is delayed in being delivered to the GFC.

#### Confidentiality

The supplier shall not disclose any information; prices, specifications or any related information on the contract with third parties unless written permission is granted by the Guyana Forestry Commission.

The Guyana Forestry Commission reserves the right to reject any or all of the quotations without assigning reason thereof.
